

# PRIVACY NOTICE for Pupils at Holy Trinity CE School

**Holy Trinity CE School** is the data controller of the personal information you provide to us. This means the school determines the purposes for which, and the manner in which, any personal data relating to pupils and their families is to be processed.

In some cases, your data will be outsourced to a third party processor; however, this will only be done with your consent, unless the law requires the school to share your data. Where the school outsources data to a third party processor, the same data protection standards that Holy Trinity CE School upholds are imposed on the processor.

**ICT Inspire** is the data protection officer. Their role is to oversee and monitor the school's data protection procedures, and to ensure they are compliant with the General Data Protection Regulation (GDPR). ## Why do we collect and use your information?

Holy Trinity CE School holds the legal right to collect and use personal data relating to pupils and their families, and we may also receive information regarding them from their previous school, LA and/or the Department for Education (DfE). We collect and use personal data in order to meet legal requirements and legitimate interests set out in the GDPR and UK law, including those in relation to the following:

- Article 6 and Article 9 of the GDPR
- Education Act 1996
- Section 3 of The Education (Information About Individual Pupils) (England) Regulations 2013

In accordance with the above, the personal data of pupils and their families is collected and used for the following reasons:

- To support pupil learning
- To monitor and report on pupil progress
- To provide appropriate pastoral care
- To assess the quality of our service
- To comply with the law regarding data sharing

#### Which data is collected?

The categories of pupil information that the school collects, holds and shares include the following:

- Personal information e.g. names, pupil numbers and addresses
- Characteristics e.g. ethnicity, language, nationality, country of birth and free school meal eligibility
- Attendance information e.g. number of absences and absence reasons
- Assessment information e.g. national curriculum assessment results

- Relevant medical information
- Information relating to SEND
- Behavioural information e.g. number of temporary exclusion
- Child Protection records where appropriate

Whilst the majority of the personal data you provide to the school is mandatory, some is provided on a voluntary basis. When collecting data, the school will inform you whether you are required to provide this data or if your consent is needed. Where consent is required, the school will provide you with specific and explicit information with regards to the reasons the data is being collected and how the data will be used.

## How long is your data stored for?

Personal data relating to pupils at Holy Trinity CE School and their families is stored in line with the school's Data Retention Policy which can be found on the school website.

In accordance with the GDPR, the school does not store personal data indefinitely; data is only stored for as long as is necessary to complete the task for which it was originally collected.

## Will my information be shared?

The school is required to share pupils' data with the DfE on a statutory basis, this includes the following:

- Children's end of Key Stage assessments
- Free School Meal entitlement
- Looked After/Adopted from care
- Special Educational Needs
- Languages spoken by child
- Ethnicity

The National Pupil Database (NPD) is managed by the DfE and contains information about pupils in schools in England. Holy Trinity CE School is required by law to provide information about our pupils to the DfE as part of statutory data collections, such as the school census; some of this information is then stored in the NPD.

The DfE may share information about our pupils from the NDP with third parties who promote the education or wellbeing of children in England by:

- Conducting research or analysis.
- Producing statistics.
- Providing information, advice or guidance.

The DfE has robust processes in place to ensure the confidentiality of any data shared from the NDP is maintained.

Holy Trinity CE School will not share your personal information with any third parties without your consent, unless the law allows us to do so. The school routinely shares your and/or pupils' information with:

- Pupils' destinations upon leaving the school
- The Local Authority
- Department for Education
- My Concern (online Safeguarding Tool)
- School Pupil Tracker Online (cloud based pupil assessment tracker)
- ParentPay (online parent payment system)
- Teachers2Parents (school to home texting service)
- G2 Integris (school management database system; this is where we hold all your child's information)
- School Nurse (where appropriate)

The information that we share with these parties includes the following:

- Personal information e.g. names, pupil numbers and addresses
- Characteristics e.g. ethnicity, language, nationality, country of birth, religion and free school meal eligibility
- Attendance information e.g. number of absences and absence reasons
- Assessment information e.g. national curriculum assessment results
- Relevant medical information
- Information relating to SEND
- Behavioural information e.g. number of temporary exclusions
- Child Protection records where appropriate

# Requesting access to your personal data

Under data protection legislation, parents and pupils have the right to request access to information about them that we hold. To make a request for your personal information, or be given access to your child's educational record, contact the school office making a request in writing to the Headteacher.

You also have the right to:

- object to processing of personal data that is likely to cause, or is causing, damage or distress
- prevent processing for the purpose of direct marketing
- object to decisions being taken by automated means
- in certain circumstances, have inaccurate personal data rectified, blocked, erased or destroyed; and
- claim compensation for damages caused by a breach of the Data Protection regulations
